Dear Applicant,

Thank you for your interest in Mountain Empire Community College (MECC).

MECC is a non-residential community college; no on-campus student housing is available. You will be responsible for making your own living arrangements.

Federal regulations [8CFR214.3(g)(3)(iii)] stipulates that every term and no later than 30 days after the deadline for enrolling in classes, all schools must report through SEVIS the following information:

- *Whether the student has enrolled at the school, dropped below a full course of study without prior authorization of the DSO, or failed to enroll in classes;*
- *The current address of each enrolled student; and,*
- *The start date of the student's next session, term or semester.*

You are required to enroll in a full course of study with at least 12 credit hours in residence. All tuition/fees for the term are due by the published deadline. If tuition/fees are not paid in accordance with the published payment deadline, you will be dropped from your classes, which could result in a violation of your F-1 visa status.

CAUTION: If you are a new F-1 student in initial status that just entered the U.S. on another school's I-20, you are eligible to transfer from your current school to MECC only if you can complete your admission and begin classes within 30 days of your arrival to the U.S. **A new MECC F-1 student in initial status can only transfer if the new school's program start date is within 30 days of your arrival in the U.S. AND provided you can produce an acceptance letter from the school you intended to transfer to.** Please be aware that admission deadlines apply!

NOTE: F-1 transfer students must begin classes within five months of the date of last attendance OR program completion date at their current school (whichever date is earlier). If the next available term does **not** begin within five months of your date of last attendance or program completion date at your current school, you may be required to depart the U.S. and re-enter the country in initial status to begin your new program. When your admission to MECC pursuant to an I-20 is complete and your SEVIS record is released to MECC, you must report to Enrollment Services within 15 days of the program start date indicated on your I-20 to complete your transfer.

Financial Requirements

F-1 applicants must provide evidence that sufficient funds are available to cover all educational and living expenses while studying at MECC. Financial support must meet or exceed MECC's estimated costs identified below:

English Proficiency Requirements

To demonstrate English proficiency, applicants must provide one (1) of the following:

- A minimum international TOEFL score of 61 iBT;
- SAT – Minimum Score ERW 450;
- ACT – Minimum Score 18;
- If in the U.S., successful completion of the MECC Placement Test;
- Transcripts from an accredited U.S. college/university for Freshman Composition;
- Evidence of possession of a U.S. college/university degree (Associate’s, Bachelor’s, etc.).

*English proficiency requirements are subject to change without notice. Except for presentation of transcripts showing successful completion of Freshman Composition at an accredited U.S. college/university or evidence of possession of a U.S.

Health Insurance Requirements

All MECC F-1 students must carry health insurance for themselves and all dependents in F-2 status. Evidence of health insurance coverage for the entire semester must be submitted during the student's first week of classes and must be continuously maintained the entire time the student is enrolled at MECC, even during the summer. If proof of health insurance is not submitted by the end of the first week of classes this could result in a violation of your F-1 visa status.

Approved insurance policies must meet minimum requirements as specified below:

- Medical benefits of at least \$100,000 per accident or illness; pregnancy and prescription coverage; emergency room coverage to the full benefit of the policy.
- Repatriation of remains in the amount of \$25,000.
- Expenses associated with the medical evacuation to the student's home country in the amount of \$25,000.
- A deductible not to exceed \$300 per accident or illness.
- A provision for co-insurance/co-payment of not more than 25% of the covered benefits per accident or illness.

**Students who enter the United States with government health insurance policies must provide the International Student Officer with a detailed description of policy benefits, in English, to demonstrate that the policy benefits meet the above requirements.*
